2. Introduction

This document is the Federal Aviation Administration (FAA) Approved Model List (AML) for Supplemental Type Certificate (STC) Number **ST01086DE**, for replacing existing Grimes power supplies with True Blue TS60 power supplies on several models of Title 14, Code of Federal Regulations (CFR), part 25, Transport Category Airplanes. Approved models are listed in Section 4.

Revisions to the AML must be coordinated between the STC holder and the responsible Aircraft Certification Office (ACO) Branch, and require FAA approval.

This AML is only applicable to the 14 CFR, part 25 aircraft listed in Section 4. Installations in 14 CFR part 23, part 27, and part 29 aircraft are not authorized under this AML.

2.1. Specific Limitations

The following limitation applies to this AML STC:

1. This STC is limited to the replacement of the previously installed Grimes 60-1321-1 or 60-3844-1 EEL power supplies with the True Blue 6340060-1.

3. Certification Basis

The certification basis for each qualified model is specified in the Type Certificate Data Sheet (TCDS) and modified by the amendment levels noted in the appendix identified in the approved model list of Section 4.
